- 1. I am the plaintiff in the above-entitled action. In that capacity, I am familiar with the facts as set forth herein.
- 2. I submit this certification in support of the plaintiff's motion for partial summary judgment pursuant and in opposition to the defendant's cross-motion for summary judgment.
- 3. The parties never entered into any written agreements to modify the scope of the agreement between the plaintiff and defendant dated September 13, 2008 (hereinafter the "Backing Agreement").
- 4. The scope of the Backing Agreement that was signed by the parties was limited to in-person, casino-sponsored, non-charity poker tournaments, and on-line tournaments were also expressly excluded by the Backing Agreement.
- 5. The large majority of the in-person poker tournaments that the Plaintiff participated in under the terms of the Backing Agreement were located in the State of New

Jersey or the State of Nevada. Attached hereto as Exhibit "A" is a true copy of a summary of the

disbursements that I made to the Defendant pursuant to the Backing Agreement, which shows

that the vast majority of the tournaments took place in either New Jersey or Las Vegas, and that

no in-person tournaments occurred in the State of Virginia.

6. To my knowledge, the Defendant never played an in-person poker tournament in

the State of Virginia during the term of the Backing Agreement, and the Defendant never asked

me to provide financing for same.

7. The Backing Agreement was prepared by me while I resided in the State of New

Jersey.

8. The Backing Agreement was signed by both the Defendant and me in Atlantic

City, New Jersey, on September 13, 2008.
